1. Introduction

1.1 University of Jaffna

The University of Jaffna was established in 1974 as a small campus on a 30-acre piece of land belonging to Parameswara College founded by the Philanthropist, Sir Ponnampalam Ramanathan. The University has grown since and is today home to ten faculties, with a student population of over 10000.

1.2 Faculty of Medicine

The very first medical school in the country was set up in the village of Manipay in Jaffna in 1848 by Dr. Samuel Fisk Green, an American missionary doctor. After its closure in 1879, the north had to wait over a century for the next medical school.

The Faculty of Medicine of the University of Jaffna was established on the 7th of August 1978 as the third state medical faculty in the country. The Provincial Hospital in Jaffna was declared the Teaching Hospital of the Faculty that year.

At first the pre-clinical course was conducted at Kaithady in the buildings of the Ayurvedic Teaching Hospital (now the Unit of Siddha Medicine, University of Jaffna). The foundation for the Faculty building in Thirunelvely was laid on November 29th 1979 by the late Prof. S. Vithianathan, the University's first Vice Chancellor.

Prof. A. A. Hoover, Professor of Biochemistry, was the founder Dean of the Faculty. His successors ably built on the strong foundations laid by him. Prof. S. Raviraj is the first alumnus of the Faculty to take up the position; the present Dean, Dr. R. Surenthirakumaran, is also an alumnus.

The Faculty went through a period of immense hardship with the worsening of the armed conflict, and had to temporarily relocate towards the end of 1995 and resumed functioning at Thirunelvely in mid-1996. Despite these setbacks, the Faculty continued to train students with the support of the extended faculty of specialists at the Teaching Hospital. The faculty has produced around 3000 doctors, with many serving with distinction.

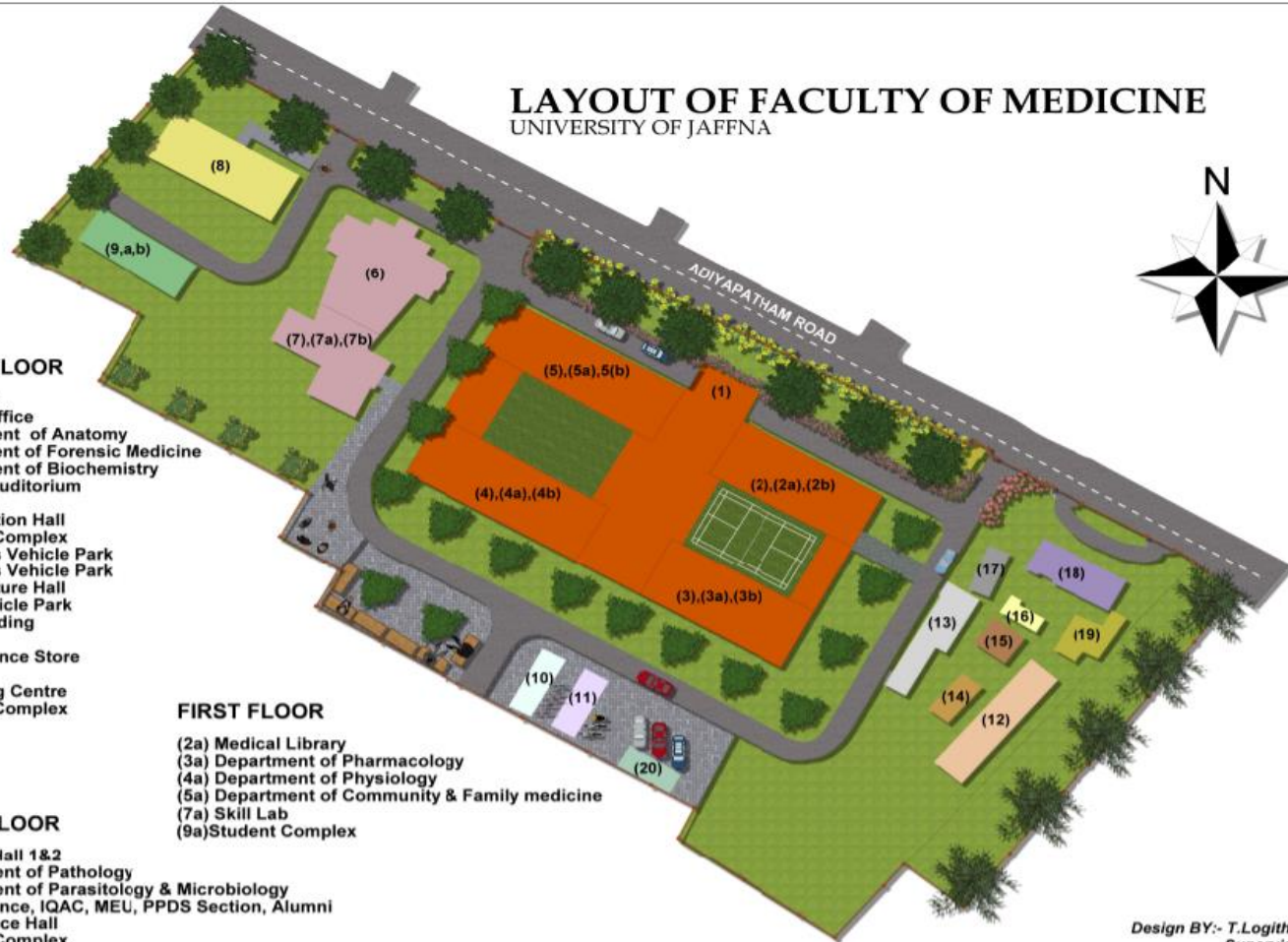

1.7 Medical Library

The Medical Library is a branch of the University's main library. It is located on the first floor of the main building of the Faculty.

The book collection of the library exceeds 16,000 and the library subscribes to a number of online periodicals. It has a collection of the latest textbooks with multiple copies, and a small collection of videos, CD-ROMs and slides.

The library is open from Monday to Friday 8 am to 6.00 pm and on Saturdays 8.00 am to 2.30 pm. It is closed on Sundays and other public holidays. Open hours of the library are subject to change based on the needs of its members.

Students can obtain their membership from the library, and borrow the materials by using their membership card.

1.8 The Computer Lab

The Computer Lab is on the first floor next to the library. The Lab has 60 internet enabled computers. Students can utilise the Lab for individual and group sessions from 9 am to 4 pm on weekdays.

2. Responsibilities and Obligations

As you begin life as an undergraduate, it is important that you reflect on the meaning of higher education and the responsibilities and obligations that come with your studentship.

Each member of the university community should fully understand the prestige of the institution and the self-esteem of its members. Therefore, all members should conduct themselves in a manner compatible with the university's quest and mission. Students must be polite in their words and actions, and should allow space for all people to live in harmony.

2.1 Student discipline

Not complying with the university rules and regulations will result in activation of disciplinary procedures as specified in the Student By-laws approved by the Council of the University. The University Student Charter (2012) published by the University Grants Commission (UGC) specifies the unethical and unlawful activities listed below.

- Plagiarism and cheating
- Disorderly conduct
- Disrespect and non-compliance
- Wrongful utilization of goods, services or information
- Unauthorized collection of funds
- Solicitation
- Possession and consumption of alcohol, drugs and tobacco within the university premises
- Gambling
- Harassment/violence
- Ragging/hazing
- Sexual harassment/sexual misconduct
- Theft
- Vandalism
- Unauthorized Entry
- Failure to cooperate with authorities and committees of inquiry

The consequences that must be faced if found guilty of any one of the above activities are serious. The Police is empowered by the *Prohibition of Ragging and Other Forms of Violence in Educational Institutions Act, No. 20* to take action against offenders.

University administrations are empowered through the UGC Circular No. 919 which sets strict guidelines to take stern action against those who commit any of the unethical and unlawful activities.

UGC Circular No. 902 of 2008 stipulates that universities should hold offenders accountable for damages to university property and charge the cost of damages from responsible individuals or deduct them from allocations made to student societies/councils.

Punishments imposed may range from recovering damages and/or issuing a

warning letter to temporary suspension from academic work and/or university residential facilities, or expulsion from the university, in addition to the punishments imposed by a Court of Law. More details regarding the unethical and unlawful activities are provided below.

Plagiarism and Cheating

Undergraduates are required to maintain high academic standards. Plagiarism (copying or reproducing work of others in reports, theses or assignments without acknowledging the source of information) is an academic offense and will not be tolerated. All work submitted must be one's own and the work of others should be acknowledged. Copying or keeping unauthorized material at examinations is strictly prohibited.

Disorderly Conduct

Conduct that violates community or university norms is unacceptable. Vulgar, rude or indecent conduct on campus or at university sponsored events held off campus, will not be tolerated. Organizing, sponsoring, or conducting programmes/ activities which are disorderly and/or violate civil laws or university regulations are prohibited.

Disrespect and Non-compliance

Failure to comply with the directives of university officials acting in performance of their duties is prohibited. Disciplinary action can be applied in such situations including, but not limited to:

- i. Use of abusive or insulting language
- ii. Use of indecent or unbecoming gestures
- iii. Providing false information to university officials
- iv. Showing disrespect or refusing to comply with a reasonable request from a university official
- v. Not responding to a reasonable request within a specific timeline, including absence from assigned appointments
- vi. Intentionally interfering with teaching
- vii. Obstructing or hindering the investigation of an incident

Wrongful Utilization of Goods, Services or Information

Students are required to demonstrate honesty in their dealings with the university and the public. The following are prohibited:

- i. Possessing unauthorized property, or offering unauthorized services.
- ii. Embezzling, defrauding or procuring money, goods or services under false pretenses.
- iii. Possessing, purchasing or receiving property, money or services knowing them to be stolen or embezzled.
- iv. Issuing a cheque for payment of dues or for any other purpose knowing that it will not be honoured.
- v. Duplicating keys, computer access codes, or other devices without authorization.
- vi. Forging, altering or causing any false information to be entered on an administrative record or presenting such information at administrative or disciplinary proceedings.
- vii. Unauthorized use of the computer system, computer access codes, and restricted areas of computer services.
- viii. Possession or use of false identification.
- ix. Possession and/or use of keys or any other devices (such as number codes or sweep cards) for access to offices or laboratories, faculty buildings or rooms of residential halls, by anyone other than those authorized by the university.

Unauthorized Collection of Funds

Solicitation of funds for a university purpose, whether organized by students or by the authority, should be pursued only with proper authorization of the Vice-Chancellor.

External communications requesting sponsorship or funds should be by letter to the external organization under the Vice Chancellor's signature. Solicitation for or collection of funds for political, charitable or social activities without approval, is not permitted within or outside the university premises.

Solicitation

No external person, organization or business may solicit on campus without the permission of the Vice Chancellor. This includes holding meetings, distributing or posting any type of leaflet, exchange, bartering or selling of goods or services.

Possession and consumption of alcohol, drugs and tobacco

The university prohibits possession and consumption of alcohol, drugs and tobacco within the university premises. Students are strongly discouraged from entering the university premises after consuming alcohol and/or drugs.

Gambling

Any form of betting, acceptance of bets, payment or running of any betting scheme is not permitted, and is punishable under the law and university regulations.

Harassment/Violence

Harassment or inciting violence inside or outside the university is a punishable offence under the civil law, which is applicable both inside and outside the university. This includes, but is not limited to, the following:

- i. Threatening and /or using physical force
- ii. Engaging in violence or commotion resulting in bodily injuries, psychological trauma and / or damages to property
- iii. Intimidation, bullying or cruel treatment
- iv. Pestering or causing annoyance
- v. Harassment through telephone, mail, emails or other means

Any complaints of the above and any other forms of harassment or violence will be referred to the Police for appropriate legal action and will be referred to a disciplinary committee of inquiry.

Ragging/Hazing

Ragging is a criminal offence under the Anti-Ragging Law passed by the Parliament in 1998.

Ragging refers to any act (by an individual or group) whether physical, mental, emotional or psychological, which subjects another person, voluntarily or involuntarily, to abuse, mistreatment, degradation, humiliation, harassment or intimidation, whether on or off the campus.

These actions include, but are not limited to, the following.

- i. Bullying, coercing, or intimidation of individuals (or groups of individuals).
- ii. Forcing individuals (or groups of individuals) to perform and/or engage in degrading acts, games or other activities.

- iii. Subjecting individuals (or groups of individuals) to physical/mental fatigue or physical/psychological shock.
- iv. Forcing individuals to wear certain types of clothing or implementing dress codes that are not authorized by the university administration.

All reported events of the above nature will be handed over to the police for action under the Anti-Ragging Law of 1998. The university will also take appropriate disciplinary action.

Sexual Harassment/Sexual Misconduct

If any person under the university administration commits an act of sexual harassment or misconduct, be it toward a person of the opposite sex or the same sex, and if a complaint is received, action will be taken under the law to bring justice and punish the offender. The University's disciplinary procedures are guided by the Sexual and Gender-Based Violence By-law No. 02 available at the Centre for Gender Equality/Equity website of the University of Jaffna.

Theft

Stealing physical goods and stealing intangible assets such as intellectual property (plagiarism) are punishable offences under civil law as well as under university regulations.

Vandalism

Vandalizing property in the university or provoking others to do so will be dealt with under the law and university regulations. Damage due to vandalism to furniture, laboratory equipment, computers and accessories, and playground equipment will be charged to the students, if they are found guilty. When student agitation causes vandalism, the cost and penalties will be charged to the organizers. In the case of isolated acts, students who are officially authorized to occupy or use the property will be held responsible and are liable to pay compensation.

Unauthorized Entry

Generally, all students are given unrestricted access during working hours to the classrooms, libraries, playgrounds, gymnasium areas, etc. Students have access to their hostels but no visitors are permitted without approval of the warden. Restrictions may be imposed on access to public areas due to various

concerns, including security matters.

Students of other universities who wish to visit the University of Jaffna must seek permission from the university authorities. Anyone found trespassing is liable to prosecution under the law and will be dealt with under disciplinary procedures.

Failure to Cooperate

Universities appoint various committees of inquiry on disciplinary matters and empowered officers may summon students to provide evidence. Failure to comply may be construed as an act of disregard and may be cause for further disciplinary action. Students are advised to cooperate with the authorities.

2.2 Right of Appeal

Right of appeal is enshrined in the fundamental rights up until the Supreme Court of the country. This principle applies to the university as well; one can appeal to the Vice Chancellor against a decision by the disciplinary authorities. This may be done collectively or individually and a fair hearing for such appeals will be given by the Vice-Chancellor.

2.3 Dress Code of the Faculty of Medicine

The dress and appearance of medical students should be appropriate to the medical profession as they engage with teachers, patients and clinical colleagues.

All students should maintain a high level of personal hygiene and appearance. Clothing should be clean and tidy and in a good state of repair.

Photographic identification badges must be carried/worn at all times in addition to the name badge and be presented as required.

Appropriate deportment and dress are applicable during working hours, whenever academic sessions are underway within the faculty premises, when students engage in community/field activities, during activities representing the Faculty or the University, and during any official engagements, including examinations.

When students are required to wear scrubs or white coats its design and colour shall comply with the specifications approved by the faculty.

2.4 Social Media Guidelines of the University of Jaffna

Students are expected to adopt the highest ethical and behavioral standards on social media. Please read the University's social media guidelines [here](#) under the student tab of the University of Jaffna website.

2.5 Conduct at Examinations

Students are expected to conduct themselves according to the examination regulations. Examination offences and minimum punishments are listed below.

- I. Possession of unauthorized documents and removal of examination stationery
 - Cancellation of candidature from the examination in which the offence was committed.
- II. Disorderly conduct of a grave nature, copying or attempting to obtain/obtaining improper assistance or cheating
 - Cancellation of candidature for 3 years including the one in which the offence was committed.
- III. Impersonation
 - Cancellation of candidature for 5 years including the one in which the offence was committed.
- IV. Aiding and abetting in the commission of these offences
 - Punishments shall be the same as for the offence

The punishments mentioned above are the minimum and may be enhanced depending on the gravity of each case.

3. The Undergraduate Medical Programme

3.1 Degrees awarded

Bachelor of Medicine and Bachelor of Surgery (MBBS)

This degree is awarded to those who successfully complete First, Second and Final Examinations for Medical Degrees

Bachelor of Medical Sciences (BMSc)

This degree is awarded to those who opt out after successful completion of First and Second Examinations for Medical Degrees.

3.2 Overview of Medical Degree Programme

The Jaffna Medical Faculty follows an integrated traditional curriculum. The duration of the course is five years, and the medium of instruction is English. The curriculum is based on the Subject Benchmark Statement in Medicine of the Committee of Vice-Chancellors and Directors (2004) and the Standards for Undergraduate Medical Education of the Sri Lanka Medical Council.

3.3 The Medical Course

The course is conducted in 3 phases: Phase I (Pre-clinical), Phase II (Para-clinical) and Phase III (Clinical). The Pre-clinical course focuses on the structure and function of the human body, with some application to clinical practice, and a brief introduction to public health. During Phase II, students go for clinical appointments in the mornings, mostly at the Teaching Hospital Jaffna, and for Para-clinical sessions in the afternoons at the Faculty. The Para-clinical subjects deal with abnormal structure and function in disease states, application in clinical situations, and disease prevention, control and health promotion. Phase III comprises the clinical course exclusively.

3.3.1 Phase I (Pre-clinical Course; Terms 1 to 4)

The pre-clinical course comprises an introductory period of 4 weeks and four terms of 10 weeks each.

The Integrated Introductory Module (IIM) combines English, IT and personal and professional development, and is designed to introduce newcomers to the university setup, student support systems, and to acclimatize students to their new environment by way of lectures, group activities, and visits to various sites (details in the IIM Student Guide).

The core subjects of the Pre-clinical Course are Anatomy, Biochemistry and Physiology. They are synchronized to facilitate understanding and correlation.

The Evidence-Based Practice and Research Module (EBPRM), which begins in Phase 1 and continues into Phase 3, introduces students to basic research

concepts in Phase 1 through lectures, practical activities, and small group discussions. Students must pass the EBPRM assessment in Phase 2 to proceed to the final year.

The Personal and Professional Development Stream (PPDS), which begins in the introductory phase, continues through Phases 1 and 2. Students should have 80% attendance in all PPDS activities to sit the end of course assessment in PPDS. Students must pass the PPDS assessment in Phase 2 to proceed to the final year.

The First Examination for Medical Degrees is conducted at the end of Phase I. The examination is held twice a year; the second examination (repeat) is held 6 weeks after the release of the results of the first examination. All students must apply to sit for the examination at the end of the course. Failure to apply for whatever the reason, will imply failure at the examination. The examination is held twice a year. It is a bar examination; students proceed to Phase II only after passing the First Examination for Medical Degrees. This means that students who fail to get through the First Examination for Medical Degrees (first and repeat) will miss their batch and spend an additional year in the pre-clinical phase.

3.3.2 Phase II (Para-clinical Course; Terms 5 to 11)

On completing the First Examination for Medical Degrees, students enter Phase II. The duration of the Para-clinical course is seven 10-week terms (terms 5 to 11).

During Phase II students are trained in the hospital and community settings in the mornings and taught para-clinical subjects in the afternoons.

Phase II Pre-professorial Clinical course

The course starts with an introductory clinical programme (4 weeks), after which students are posted for Pre-professorial clinical appointments in core clinical subjects (Medicine, Surgery, Obstetrics and Gynaecology, Paediatrics and Psychiatry) and subspecialties (e.g. Neurology, Neurosurgery, Cardiology, Oncology, Anaesthesia and Intensive Care, Radiology, Venereology, Clinical Pathology, etc.). An appointment each in Community Medicine and Family Medicine are conducted in community settings. Lastly, students complete elective appointments for four weeks.

Phase II Para-clinical course

The course is conducted in the afternoons on weekdays. Microbiology, Parasitology, Community & Family Medicine, Forensic Medicine, Pathology and Pharmacology starts in term 5 and continues to term 11. Lectures in Paediatrics, Psychiatry and Surgery and the second phase of PPDS and EBRPM are also conducted in the afternoons.

Second Examination for Medical Degrees

Part I of the Second Examination for Medical Degrees is conducted at the end of Term 9 (Microbiology, Parasitology and Forensic Medicine). Part II is held at the end of Term 11 (Pharmacology, Pathology and Community and Family Medicine).

Results of the Second Examination for Medical Degrees (1st) are released 6-8 weeks after the commencement of the examination. For those who fail in the 1st (Part I & II) examinations, the 2nd (repeat) examination is conducted 6 weeks after the results of the 1st examination are released. The 2nd (repeat) examination results are released 4 weeks after the date of commencement of the examination.

Part 1 and Part 2 results are released separately indicating pass/fail. Class and distinction results of the whole Second Examination for Medical Degrees are released at the end of Phase II. (For further information refer the Curriculum Book Volume I available under the [courses tab](#) on the Faculty website.)

3.3.3 Phase III (Clinical Course; Final Year)

Before entering Phase III, an OSCE is conducted to ensure that the students have acquired the necessary clinical knowledge and skills to proceed to the final year. The marks from this OSCE are added to the continuous assessment (in-course) marks of the contributing subjects.

The students are then posted to the eight-week professorial appointments in Medicine, Surgery, Paediatrics, Obstetrics & Gynaecology and Psychiatry. Students who complete all their clinical appointments to satisfaction are eligible to sit for the Final Examination for Medical Degrees, which is conducted twice a year.

3.4 Student Attendance

3.4.1 Attendance Requirements

Phase I (Pre-clinical Course):

The attendance will be evaluated at the end of terms 3 and 4. The students should have 80 % attendance in practical and tutorial sessions of all subjects including PPDS I and 100% attendance in the PBL sessions (Up to 10% absenteeism in could be acceptable with valid reason accepted by the Phase coordinator). Students whose attendance is found to be inadequate will be instructed to follow the course with the subsequent batch. If such student fails to show 80 % attendance in the repeated period, that student will be referred to a special committee of three Senior Teachers to analyse the problem of the student and to suggest appropriate course of action. The suggestion will be placed before the Faculty and the Senate for final decision. All students who repeat the course will lose eligibility for class at the First Examination for Medical Degrees unless the Faculty Board and the Senate accept the explanation given by the student as valid.

Phase II (Para-clinical Course):

The attendance of the para-clinical courses will be evaluated at the end of the terms 7, and 11. The students should have 80 % attendance in practical and tutorial sessions of all subjects including PPDS II and 100% attendance in the PBL sessions, Multidisciplinary seminars and EBPR module activities (Up to 10% absenteeism could be acceptable with valid reason accepted by the Phase coordinator).

The attendance in the clinical appointments in Forensic medicine, pathology and Community and Family Medicine will be considered as 100%.

Students whose attendance is found to be inadequate will be instructed to follow the course with the subsequent batch. If such student fails to show 80 % attendance in the repeated period, that student will be referred to a special committee of three Senior Teachers to analyse the problem of the student and to suggest appropriate course of action. The suggestion will be placed before the Faculty and the Senate for final decision. All students who repeat the course will lose eligibility for class at the first examination for medical degrees unless the Faculty Board and the Senate accept the explanation given by the student as valid.

Phase III (Clinical Course):

Students are required to have 100% attendance for the clinical training appointments. Those absenting themselves due to sickness or any other valid reason should discuss this with the clinician responsible and get his/her approval. Students absenting themselves should come on extra days and catch up the lost clinical work. The clinical coordinator should be informed regarding the leave and catch-up days in clinical appointments.

Students who need leave to attend to a personal matter must obtain prior permission from the relevant clinician responsible and a copy of the letter should be forwarded to the clinical coordinator. In addition to the prior approval the student should do the additional days to catch up on the days of absenteeism.

Satisfactory completion of the clinical appointments is an essential criterion to sit all continuous and end of course examinations in clinical subjects.

Clinical Lecture Demonstrations (CLD) during the final year:

It is **compulsory** for a final year medical student to have 90% attendance in CLD to complete the professorial appointment and to become eligible to sit the final MBBS examination.

The attendance at the pre professorial clinical appointments will be assessed at the end of the postings. Students with less than 90 % attendance in any clerkship and the absence up to the balance 10 % not approved by the consultant, the student will have to repeat the appointment with the same consultant if that consultant is agreeable or under another consultant who will accept the student and sign the completion of the appointment.

Students who are on leave without any communication either with the clinician responsible or clinical coordinator will repeat the whole appointment.

The Clinical Coordinator will permit students to go over to professorial appointments only on satisfactory completion of the prescribed pre-professorial appointments. Students who fail to commence professorial appointments with the proper batch lose eligibility for class unless the excuse given by the student is accepted by the Faculty and Senate as valid.

3.4.2 Record Book

Students must obtain their record books from the Office of the Dean. Record of satisfactory completion of academic and clinical work will be entered in the record book at the end of each term or clinical appointment and certified by the authorized person. A student cannot sit for examinations if the record book is not certified.

3.4.3 Leave

3.4.3.1. Medical Leave

In case of illness for more than 3 days a letter should be submitted with the medical certificate to the dean. The Medical certificates should be approved by the University Medical Officer and the leave should be approved by the University Senate. The period of sickness due to absenteeism must be repeated on a later date.

Any student who is unable to attend classes or clinicals to sit an examination due to ill health should meet the UMO. If the student is too ill to travel, he/she

should inform the UMO within two days of falling ill (via telephone no 021 221 8130 or letter) and forward a medical certificate (from a medical consultant, DMO or MOH) to the UMO within three days of the last day on medical leave. Three weeks from the last day is permitted if the student has been hospitalized. If and when necessary, the UMO will arrange a medical board to consider a student's request for medical leave.

3.4.3.2. Special leave:

A duly filled application form is needed for all students registered with the faculty of medicine if they are absent from academic activity for more than one week. Indicators are leave for overseas travel or participating in a sports event/conference or any other leave of absence. Application form is available on request at the Dean's office.

3.5 Student Assessment

Each subject will be evaluated by the respective department through continuous (in-course) assessments and end-of-course examinations.

3.5.1 Continuous Assessments

Students must attend all continuous (in-course) assessments. If a student is absent for a valid reason, the department concerned may conduct another assessment either in written or oral form. The student may request for another assessment in writing to the Dean through the coordinator. If students are absent for trivial reasons, they will be given zero marks for that assessment. A portion of the final marks of the end-of-course examination (1st attempt) will be obtained from continuous (in-course) assessments.

3.5.2 End-of-course Examinations

Examinations are conducted at the end of each Phase. A second examination (repeat) will be conducted 6 weeks after releasing the results. Each subject will be examined separately, and will have several components such as MCQ, structured essay questions, practicals, spot examination, OSCE/OSPE, viva and clinical examinations. Components may vary according to the subject.

Eligibility for the First Examination for Medical Degrees

- Valid registration in the University.
- At least 80% attendance in practical and tutorial classes of all the subjects.
- Completion of the course in all subjects with the signature of the Head of each Department in the record book and the application form.

Eligibility for the Second Examination (Part I)

- Valid registration in the University
- At least 80% attendance in practical and tutorial classes of the three subjects.
- 100% attendance in the Forensic Medicine appointment.
- Completion of the course in all subjects with the signature of the Head of each Department in the record book and the application form.

Eligibility for the Second Examination (Part II)

- Valid registration in the University.
- 100% attendance in the clinical appointments in Pathology, Community Medicine and Family Medicine (with approval of <10% absenteeism from the relevant Head of Department)
- Completion of the course in all subjects with the signature of the Head of each Department in the record book and the application form.
- Pass the Evidence Based Research Module
- Pass all the components of PPDS

Eligibility for the Final Examination for Medical Degrees

- Valid registration in the University.
- 100% attendance in the clinical component; up to 10% absenteeism in the clinical component could be acceptable with written permission of the Consultant/Head of the Department.
- At least 80% attendance in other relevant components of all the subjects.
- Completion of the course in all subjects with the signature of the Head of each Department in the record book and the application form.

(Refer p. 240-242 of Volume I of the Curriculum Book)

3.5.3 Attempts and Excuses

The examination scheduled immediately after the completion of the course shall be deemed to be the first attempt.

Students will be allowed to sit 4 scheduled attempts at the First Examination for Medical Degrees.

For the Second Examination for Medical Degrees and Final Examination for Medical Degrees students will be allowed to sit 6 scheduled attempts for each examination.

As per the decision of the Council at its 462nd meeting held on 27.02.2022 , the maximum permissible period (MPP) of a student to hold his/her studentship period of MBBS program is ten years.

If any student misses the scheduled examination for not fulfilling the above-mentioned criteria or for other reasons, the student will be deemed to have failed that examination unless the excuse is accepted by the Faculty Board and the Senate.

If any student is unable to appear at the examination due to ill health, the student should get examined by the University Medical Officer (UMO), a Consultant at the Teaching Hospital, or a Government Medical Officer. The medical certificate should be duly certified by the UMO and submitted to the Faculty within two weeks of the examination.

A grace chance may be granted under exceptional circumstances for students who have not completed an examination within the stipulated number of attempts, if the appeal of the student is supported by authenticated documents and accepted by the Faculty Board and approved by the Senate.

3.5.4 Award of Pass, Fail, Distinctions and Class

The examinations of the Phase I, II and III courses will be independent; the results of one examination will not have any bearing on the results of other examinations. Pass, class and distinctions will be awarded for each examination, separately.

Award of Pass in a Subject

- Students should obtain 50% or above and the qualifying marks in the specified components to pass a subject.
- The qualifying mark is 45% in the theory component [MCQ and Essay] in each subject; the qualifying mark for the clinical subjects is 45% in theory [MCQ and Essay] and 50% in the clinical component [short case and long

case].

- The Community & Family Medicine assessment has five components. Students must obtain at least 45% marks in each component. They must also obtain a total of 50 marks to pass the subject. If the student fails to obtain 45% marks in a component (except for continuous (in-course) assessments), the student is expected to sit for the component in the successive allowed attempt. If the student does not obtain a total of 50 marks, after successfully passing all five components, they must sit for the written and viva exam in the successive allowed attempt, to obtain 50 marks.

Award of Fail and Referred in an Examination

- A student who fails to appear at a scheduled examination will be deemed to have failed that examination unless the excuse is accepted by the Faculty Board and approved by the Senate.
- If a student obtains less than 25% in any one subject, the student will fail the entire examination, irrespective of the marks obtained in other subjects.
- If a student obtains less than 50% in all subjects, the student will have failed the examination.
- If a student fails to obtain the qualifying mark in a component, the student will fail that subject irrespective of the total marks obtained.
- If a student passes one or more subjects and fails to pass in other subjects, the student will be deemed to be referred in the unsuccessful subjects.

Award of Pass and Class Honours in an Examination

Pass will be awarded to students when they obtain pass marks in all subjects of the course.

Class Honours will be awarded to students only if they complete the course in the first scheduled attempt and obtain average marks as specified below as per the University Grants Commission - Establishments Circular Letter No. 07/2017 dated 31st March 2017.

50-59	Pass
60-64	Second Class Lower
65-69	Second Class Upper
70 or above	First Class

Award of Distinction

Distinctions in subjects will be awarded to students who get 70% or above in any subject, if they have got pass marks in all subjects of the examination at the first scheduled attempt.

Award of Bachelor of Medical Science [BMSc]

The degree of BMSc will be awarded to those students who wish to leave the University after successful completion of the Second Examination for Medical Degrees.

The BMSc may be converted to MBBS in the future provided the student returns within a period of 5 years from the date of award of BMSc and completes the MBBS within the remaining period to make a maximum period of 10 years in the University.

A student voluntarily can opt out of the full MBBS programme and in that case will be awarded pass/class with distinction based on the first attempt at the second examination for medical degrees.

3.5.5 A note about the final examination

The final examination consists of a common MCQ for students of all medical faculties set by examiners representing all the medical faculties and a clinical examination made up of similar components and standards ensured by participation of external examiners. A common merit list is compiled based on the results of the final examination.

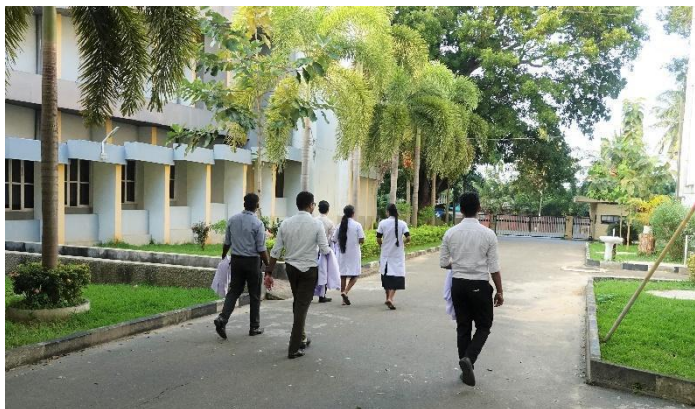


Figure 14 : Students strolling by the Hoover Auditorium

3.6 Internship

After successful completion of the Final Examination for Medical Degrees, students should undergo a one-year internship in two major clinical disciplines (6 months each) to be eligible to practice medicine in Sri Lanka. Internship postings are made by the Ministry of Health based on the common merit list. The common merit list is prepared by the University Grant Commission based on the performance at the MCQ paper and clinical components at the Final MBBS Examination.

4. General information and Student Welfare

4.1 Registration

Students must renew their registration at the University each year. Students will be notified by the Dean's Office when it is time to renew their registration. The relevant forms are available at the Dean's Office. The registration fee should be paid at a branch of the People's Bank and the completed forms and bank receipt handed over to the Dean's Office.

4.2 Student Identity Card

On admission, students must obtain their student identity cards from the Admissions Branch. This card should be carried by students at all times, and produced when required. Any change of address must be brought to the notice of the Dean and Admissions Branch.

4.3 Fees

4.4 Student Welfare

The University of Jaffna has various student welfare facilities.

4.4.1 University-wide services

University Well-Being Centre

The University Well-Being Centre is at the main campus. Students may drop in at the Centre for rest, relaxation, counselling, information, internet browsing, life skill courses, and leisure activities. The Centre has staff trained in counselling who may be reached via the hotline (021 221 4067, 076 008 4067)

Student Counsellors

Student counsellors are available at the Faculty and can be approached at any time for advice or assistance when students encounter problems. They are also responsible for maintaining overall discipline within the University premises. Details of student counsellors are available here under the counseling services tab of the Faculty website.

Student Accommodation

The medical students' hostels are located near the Teaching Hospital Jaffna, namely the Kanagasuntharam Hostel for male and Sivagnanasundram Hostel for female students, respectively.

The Faculty Hostel Committee oversees the allocation of rooms at the two hostels. Priority is given to first and final year students. When allocating rooms for others, distance of permanent residence, living status of parents, health, finances, number of school- or university-going siblings, and other special circumstances are considered.

Students are given accommodation for one year at a time. Final year students must vacate the hostel immediately after the exam. Those who fail an exam are allocated rooms after the results are released, for one repeat exam only. Others should vacate at the end of one year.

Hostel regulations must be strictly adhered to at all times.

Recreation

Sports facilities are coordinated by the Physical Education Unit of the University of Jaffna. Athletics and team sports like basketball, netball, volleyball, elle, cricket, football, rugby, and other games like badminton, table tennis, carrom, chess, karate, taekwondo, wrestling and weightlifting are available. The practice schedule is available here at the Physical Education Unit website.

University Health Services

The University Health Centre is located on the main campus. Registered students are eligible to use the services offered by the Health Centre. Students must register and get a health card to access the services. The Health Centre is open from 8.30 a.m. to 3.30 p.m. on all weekdays except public holidays.

Centre for Gender Equity and Equality (CGEE)

The University of Jaffna is committed to promoting Gender Equity/Equality (GEE) and fostering an environment free from all forms of discrimination and harassment. The University adopts a policy of zero tolerance to Sexual and Gender Based Violence.

The University's Policy Framework on Gender Equity/Equality and the Sexual and Gender-Based Violence By-law No.02 guides the activities of the CGEE and mechanisms of accountability at the University. More information is available at the Centre for Gender Equality/Equity website of the University.

4.4.2 Welfare services at the Faculty of Medicine

Welfare services at the Faculty of Medicine are under the purview of the Wellbeing Cell, Student Welfare and Wellbeing Committee and the Dean's Office. Several activities and programmes exist to support students.

Student Support System

The Faculty of Medicine has a unique support system that can be accessed through a range of contact points. Before incoming students arrive at the Faculty, the Dean's Office assigns a mentor to each student. When students face problems, they may seek their mentor for guidance.

Apart from mentors, students may seek advice from a student counsellor or any teacher they feel comfortable with. The contact details of student counsellors are available on the Faculty website. Contact details of the teachers are available on the website under the relevant department.

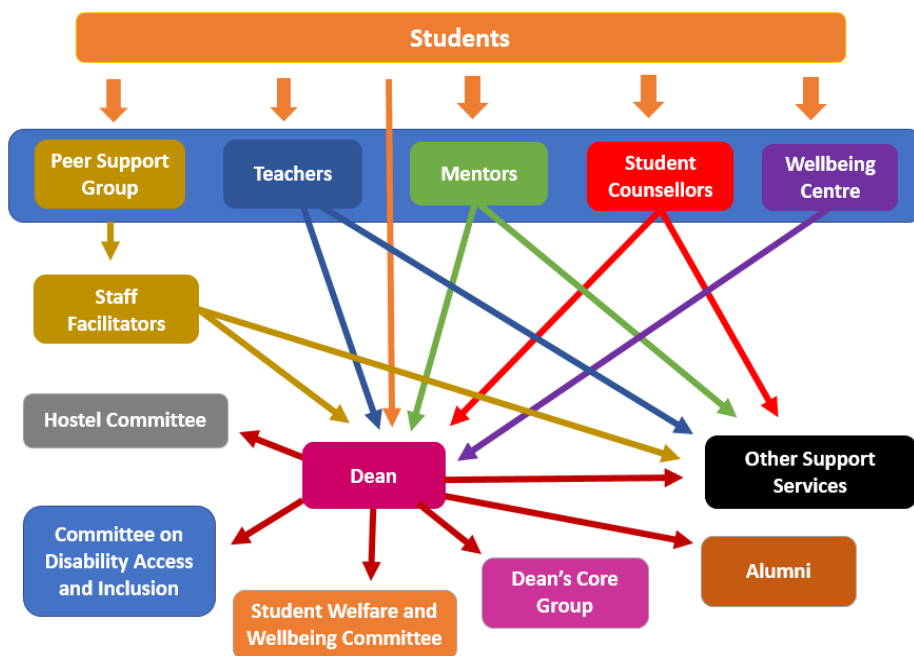


Figure 15 : Faculty of Medicine Student Support System

A peer support system is available for students who are reluctant to reach out to their teachers. The Peer Support and Wellbeing Group (PSWG) functions under the Medical Student Union with student facilitators from all batches. Students may take their problems to a student facilitator of the PSWG. If the problem cannot be resolved at the student level, the student facilitator will direct the student to a staff facilitator for support. Alternatively, students may access the support services offered by the Faculty Wellbeing Centre (see 4.38).

Through the above contact points, students can access the support services available at the Faculty to address a range of problems, including academic and financial issues, accommodation, health and other psychosocial problems (Figure 15).

If a student experiences any form of harassment or violence, the student should immediately report the incident to his/her mentor or any other teacher at the Faculty. Strict confidentiality will be maintained when dealing with student issues.

Faculty of Medicine Wellbeing Centre

The Wellbeing Centre is situated to the east of the Faculty. Students may drop in at the Centre for rest, counselling, learning support, and other activities. Space for discussions with peers, teachers or mentors is available via prior booking. Counseling and health services are available by appointment. The Centre is open to students from 8 am to 4 pm.

Mentor Programme

The Mentor Programme pairs each incoming student with a mentor. A mentor is an experienced, trusted person who is interested and willing to support, guide and motivate a student (mentee) to make the most of his/her student career. Mentors are faculty members, consultant or senior medical officers. The objectives of the Mentor Programme are to: improve student wellbeing; enhance personal and professional development; motivate students to be engaged in academic and social activities at the Faculty; sensitise students to the available opportunities and resources; and provide career counselling and guidance.

Committee on Disability Access and Inclusion

The Faculty of Medicine is committed to working towards creating an environment that is welcoming, accessible, and empowering to students with disabilities and special learning needs. The [Policy on Disability Access and Inclusion](#) outlines the procedures available for students to request accommodation and adjustments. Students are encouraged to disclose their need, with appropriate documentation, as soon as possible, for consideration by the Committee on Disability Access and Inclusion. Monthly seminars are organized by the Student Welfare and Wellbeing Committee for the first-year students. The seminars are expected to facilitate interaction between the freshers and the faculty community, and create awareness among students about the realities of life as a medical student. Senior students, faculty members, and Alumni are invited to speak on topics of general interest, including their faculty or career experiences, hobbies, and/or social issues. Students are encouraged to participate.

Medical Student Union (MSU)

The Medical Student Union (MSU) looks out for the welfare of medical students. All registered students of the Faculty of Medicine are members. The

affairs of the Union are managed by the office bearers elected in accordance with the Ordinance under the Universities Act No.16 of 1978.

The MSU has been pivotal in identifying and enhancing the talents of students by providing platforms for student activities, ranging from sports to cultural activities, including Medicos Nite, Medicos Week and festivals such as Thai Pongal, Vaani Vila, Oli Vila, Vesak, Ifthar, and Christmas.

The Peer Support and Wellbeing Group (PSWG), which functions under the MSU, aims to identify and support students facing academic, financial and psychosocial problems and organize activities to develop life skills and enhance student wellbeing (see 4.3.7).

The MSU extends services through the Student Centre, which has a photocopy unit, IT centre, and gym. The photocopy unit opens from 9.30 am to 4.30 pm, and the Centre is open to students until 10.30 pm.

The main function of the Alumni in relation to student welfare is coordinating financial assistance to students and supporting the general development of the Faculty. More information is available [here](#).

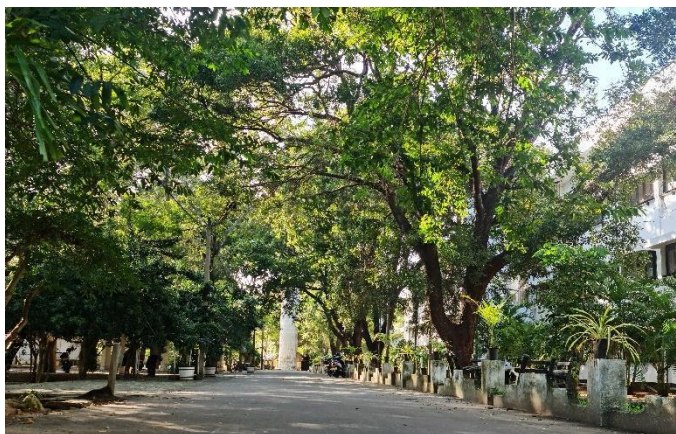


Figure 17 : Rear of the Faculty

On admission

Malayan Ceylonese Bursary

UK Sri Lankan Medical and Dental Doctors Association Bursary

Awarded to two needy medical students entering the Medical Faculty on their first attempt, depending on their parent/guardian's income, and not receiving any other assistance. If the student receives the Mahapola Scholarship/Bursary and the parent/guardian's income is less than Rs. 2,000/= per month, the student remains eligible.

Anandakumaraiah Bursary

Awarded to a deserving and needy student entering the Faculty of the Medicine, until the completion of the course. Founded in 2002 by Mr. N. Anandakumaraiah of London, UK.

Mr. Aruliah and Mrs. Thialmuthu Sinniah Memorial Award

To be awarded to five students who receive neither Mahapola nor a Bursary. They should pass their examinations in the first attempt if they are to receive the award continuously. Founded in 1990 by Dr. P. Ratnasabapathy of Kaithady.

Dr. G. M. Selvakone Memorial Bursary

To be awarded to three needy Tamil students preferably from war-affected families. Awarded by the Dr. G.M. Selvakone Memorial Research Organization, Ontario, Canada.

Mrs. S. Nadarajah Award

For a needy and clever medical student from the Columbuthurai area throughout his/her undergraduate career. Founded in 1990 by Mrs. S. Nadarajah of Jaffna.

Illankai Tamil Sangam USA Bursary

Awarded to two needy medical students with consideration to their financial position. Donated by The Association of Tamils of Sri Lanka in the USA in 2002.

Pre-Clinical Phase

Wilson Nicholas Gnanasooriyar Memorial Bursary

Awarded to a deserving student who needs financial assistance, on completing the First examination. Preference to be given to a student who has lost his/her father. Established by Mrs. P. Gnanasooriyar in 1994 in memory of her son late Wilson Nicholas Gnanasooriyar, who was a medical student.

Sivathamilchelvi Dr.Thangammah Appakuddy Bursary

Awarded to two needy students who pass the First Examination. Donated by Sivathamilchelvi Dr. Thangammah Appakuddy.

Awarded to two deserving candidates based on the performance at the Second Examination. Donated by Prof. A.J. Wilson of Canada.

Chemical Industries (Colombo) Ltd. (CIC) Bursary

Awarded to two deserving candidates amongst those securing the first ten places in the Second Examination. Awarded by the CIC Charitable and Educational Trust Fund.

4.5 Gender Cell of the Faculty of Medicine (GCFM)

Awarded to the student who scores the highest marks in the clinical component in Surgery at the Final Examination among the students who obtain class honours.

Dr. Muruganathan Gold Medal for best performance in Psychiatry

Awarded to the candidate who obtains the highest marks in Psychiatry at the Final Examination and obtains at least a Second Class. Donated by the family members of Late Dr. N. Muruganathan, an eminent Psychiatrist in the UK. The award is a half-sovereign gold medal (4g).

5.5 Overall performance

Nanthi Gold Medal

Awarded for best overall performance at all examinations in the medical course. Founded by well-wishers to felicitate Prof. C. Sivagnanasundram ('Nanthi').

Dr. William Paul Award

Awarded to the candidate with the best academic record who has also shown a significant contribution to extracurricular activities. Awarded by Mr. A.T.S. Paul, FRCS, and Mr. P.M. Jeyaranjan, Bar-at-Law of Colombo in memory of their grandfather Dr. William Paul.

Dr. Rajani Thiranagama Memorial Award

Awarded to the student who gets the highest points for extracurricular activities throughout his/her medical career at the faculty. Donated by Dr. Uthayakumaran Somasundaram.

Prof. A. Thurairajah Gold Medal for All-Round Performance

Graduates with First Class or Second Upper Division are eligible to apply for the Gold Medal. Awarded to the applicant (or jointly) who earns the highest aggregate points.

University Prize (Thambiah Muthaliyar Chatram Trust)

To be awarded to the best students of all Faculties of the University based on performance at examinations. The details for the Medical Faculty are as follows: Average marks must be 60% or above at the First, Second and Final Examinations for Medical Degrees.

Covinthapillai Candiah Research Award

Awarded to the best three researches undertaken by students in Phase I and to the best three researches undertaken in Phase II, provided the research is of sufficient merit. Founded in 1992 by Mr .C, Kandiah of Ariyalai, Jaffna.

Velayuthar Sothinagaratnam Memorial Award for Research

Awarded for the best research in Community Medicine in the field of Microbiology. Donated by Mr. S. Sothimaheswaran from UK.

Prof. Appakutty Sinnathamby Award for Research

Awarded for the best research in reproductive health related topics in Community Medicine. Donated by Mr. R. Kaneshalingam son-in-law of late Prof. A. Sinnathamby.

Dr. Muruganathan award for research in Mental Health

Awarded to the research which got the highest marks in the field of mental health among undergraduate researches conducted in Community and Family Medicine. The candidate should have a pass in the Second Examination for Medical Degrees. The award includes a cash prize of Rs. 25,000.
